

This day I a regular practicing physician of Virginia of 12 years experience being summoned by Mr Samuel Via a justice of the peace of Franklin Co Va. acting as coroner upon the view of Edward Nolen [struck] lying dead. at the residence of Thos H Spencer, after being duly sworn and upon a careful examination of the body of deceased in presence of acting coroner & Jurors and bystanders, find that Edward Nolen came to his death in my judgment by gun shot wounds. Two large wounds in back to the left of spinal column very large either sufficient to produce instant death. there was a wound of bowels as if with a load of buck shot or slugs of lead. completely riddling bowels of right illiac region. Vermiform appendix hanging out of one of the wounds..
